The **Max Planck Online Workshop in Comparative Political Economy** (MAX CPE) is an online seminar series in Comparative Political Economy, hosted by the Max Planck Institute for the Study of Societies and coordinated by Arianna Tassinari, Björn Bremer, and Lucio Baccaro.

Inspired by the success of online seminars in neighboring fields, this online seminar series aims to foster exchanges, connections, and conversations in the global community of scholars of Comparative Political Economy (CPE) and beyond.
