


Ratings of the U.S. versus different types of regimes










The Distribution of Pretax Income Growth in Europe and the United States, 1980-2017


(b) Average Annual Pretax Income Growth by Percentile





Campaign Funding Increasingly Dominated by the Ultra-Wealthy

Shares of federal contributions from the top 0.01% of VAP (1 per 10,000 voters) and the top 400 donors (1 per ~650K voters) reached record levels in 2024





Share of total campaign contributions by donor size, 2008-2024





Plutocratic: With rise of extreme inequality, corporations & conservative superrich increasingly central to GOP priorities & strength





(Right-Wing) Populism:
Intensifying ethnonationalist appeals by elites & surrogate groups to voter base not enthused by plutocratic priorities

Organized forces= Christian Right, NRA, right-wing media, etc.

Growing attraction to anti-democratic rhetoric/strategies



The Billionaire Boom: Inequality Grows Even at The Very, Very, Very Top

In 2024, starting wealth was the biggest driver of billionaire gains. Among the 100 richest Americans, the top 10 now control 50% of their combined wealth of \$4,046B-highlighting an even greater concentration of wealth at the very top.

Influence Runs Both Ways, But Increasingly From Trump

- Note prominence of "Attention Merchants"
 - Platforms generate vast wealth and vulnerability
 - Thelen: Cloud computing/AI highly capital intensive
 - Weaponization of administrative state (*regulatory* protection racket). SEC, FCC, DOJ, IRS, FBI)
- President's Potential Leverage Over:
 - Traditional media (Washington Post, LA Times; ABC, CBS settling lawsuits w/payouts, etc.)
 - New Media (Facebook, TikTok)
 - All Corporations (e.g. Tariffs)


- U.S. Republicans' Distinctive "Plutocratic Populism"
 - "Formative Rift" Over Race
 - Extreme inequality/rise of oligarchy
- U.S. Constitutional framework *extremely* vulnerable
 - Ease of capturing a party
 - Breakdown of Madisonian checks and balances w/ extreme party "team"
 - Fundamental biases against metrobased, pro-government party—that is, Democrats [next part]


American Authoritarianism


- Rise of "Strongman Presidency" (Moe & Howell)
 - Massive corruption
 - Packing of "power ministries" with loyalists
 - "Weaponization" of agencies (FCC, DOJ, etc.)
 - Attacks on civil society (universities, media, law firms, labor)
 - MAGA-fication of security forces
- Collapse of "checks & balances": Courts, Congress, perhaps checks on military use in domestic affairs
- Intensified efforts to tilt 2026 midterm elections (gerrymandering, voter suppression/intimidation)




The Center-Left in the Knowledge Economy (KE): A Tragedy in Three Acts

Act I: The Neoliberal Turn

Act II: The Long Political Tail of the Financial Crisis

Act III: The "Brahmin Left" vs. Right-Wing Populism

- The KE professional class over the working class
- Social liberalism over economic liberalism (growing literature, including role of media)
- KE agglomeration = safe urban districts = increasing left electoral inefficiency and fractionalization




Crisis of the Center-Left

- Exodus of white working class/rise of KE→decline/transformation
 - Multi-racial, cross-class party centered in metro America
- Yet even compared with center-left parties in other majoritarian democracies, U.S. Democrats look pretty good
 - Vote share (though vote → power is biased)
 - Governance (though U.S. unified power rare)—e.g., 2021-22
 - 2024 was a global story of incumbent loss
- Still, Democratic Party ill-equipped against plutocratic populism—especially today
 - System biased against party of density
 - Electorate biased against party of the system


Democrats are Really Economically and Racially/Ethnically Diverse

% of registered voters who are ...



Excludes years where fewer than five countries had elections





Density Paradox: Big rewards for density in the economy, big penalties for it in American politics.

- Density central to economic growth in KE
- US political system biased *against* density:
 - Unusually territorial (Senate, Electoral College, Single-Member Districts in House and Statehouses)
 - Rewards parties whose voters are broadly distributed rather than concentrated




The Senate has had a pro-Republican representation bias since 1979

Injunction Lifted by SCOTUS Lifted (Post-CASA Narrowing)




Democrats' "Brand" Problem


Seen as

- Democrats have limited influence on how their brand gets defined


Age Distribution of Democratic Senators vs. Registered Democrats




Party Favorability, 1992–2025 Data from Gallup Poll Social Series





It illustrates that *Fox* focused on racial issues/protests and the alleged support of elite Democrats for protesters' tactics/demands, as well as on downplaying the severity of the COVID-19 pandemic while playing up President Trump's response to it. "Across platforms — YouTube, Rumble, Twitch, Kick, Spotify, Facebook, Instagram, and TikTok — right-leaning online shows accounted for roughly 82% of the total following of the online shows we assessed."

"Right-leaning online shows had at least 480.6 million total followers and subscribers — nearly five times as many as left-leaning."

From a study of 320 online shows with a right-leaning or left-leaning ideological bent. Each circle represents a show with a total following more than 1 million, with circle size proportional to total following as determined with subscriber and follower data collected on February 3, 2025, from YouTube, Spotify, Rumble, Twitch, Kick, Facebook, Instagram, and TikTok.





Potential Sources of Resilience

- Trump Isn't Popular, and Pendulums are Real
 - Much of what he wants to do also won't be popular
- Still Lots of Resistance Built In
 - Tiny House Majority
 - Highly Legalized Governance Structures (delay, blocking is often possible through litigation)
 - Decentralization of authority structures remains (e.g. federalism). It is a big and diverse country.
 - Constitution Very Hard to Change
- Clock is Ticking: Is There Trumpism After Trump?

Trump underwater on all key issues

Average job approval rating for Donald Trump overall and on issue-specific poll questions. For issues, averages are a mix of a 14-day moving average and modeled estimates.*










2025 Off-Year Elections

But...

- Pace of Backsliding is Alarming
- Continuing packing of key institutions with loyalists (termites in the basement)
- Does Trump *need* to be popular? (Again, power without popularity)
 - Minoritarian institutions (Senate, powerful Supreme Court)
 - Tightening grip on law enforcement/military
 - Support of Oligarchs/Attention Merchants

Democrats' Response Crucial

- Strictest two-party system in the world—Democrats *are* the opposition party
 - Elections and the opposition crucial in other backsliding cases ("U-Turns"; "democratic recoveries")
- Whether opportunities arise is mostly structurally determined, but Democrats can *contribute* to their emergence
- Most important, Party must be ready.

The Democrats' Dilemma

Democrats need to build a "big tent," encompassing moderate (and even disenchanted center-right) & progressive voters and groups.

But they also need to do really big things.

Huge tensions between these two goals, as well as among the big things they need to do (especially political reform vs. "delivering the goods").

Why It's a Dilemma

- Winning power is necessary but not sufficient condition for rescuing, much less reconstructing, American democracy
- Democracy reform comes first
 - Filibuster, Supreme Court, statehood for DC/Puerto Rico, electoral reform (esp. gerrymandering), updating statutes to clarify purposes/prevent executive aggrandizement
- But also have to address voter backlash
 - How much does policy matter here?
- Huge challenge of dealing with oligarchy ("Lina Kahn problem")
- All these things are going to reduce the size of the tent
